She gave clarification on what defines Qualifying Materials and shed some light on the impact that the changes in legislation in 2024 and “Simpler Recycling” will have on the consistency in collection and on MRFs operations.

The interactive version allows for greater examination of the mapping data and highlights the trends and fluctuations by comparing the latest figures with previous years' results.

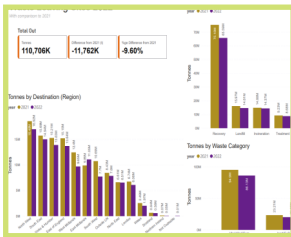
