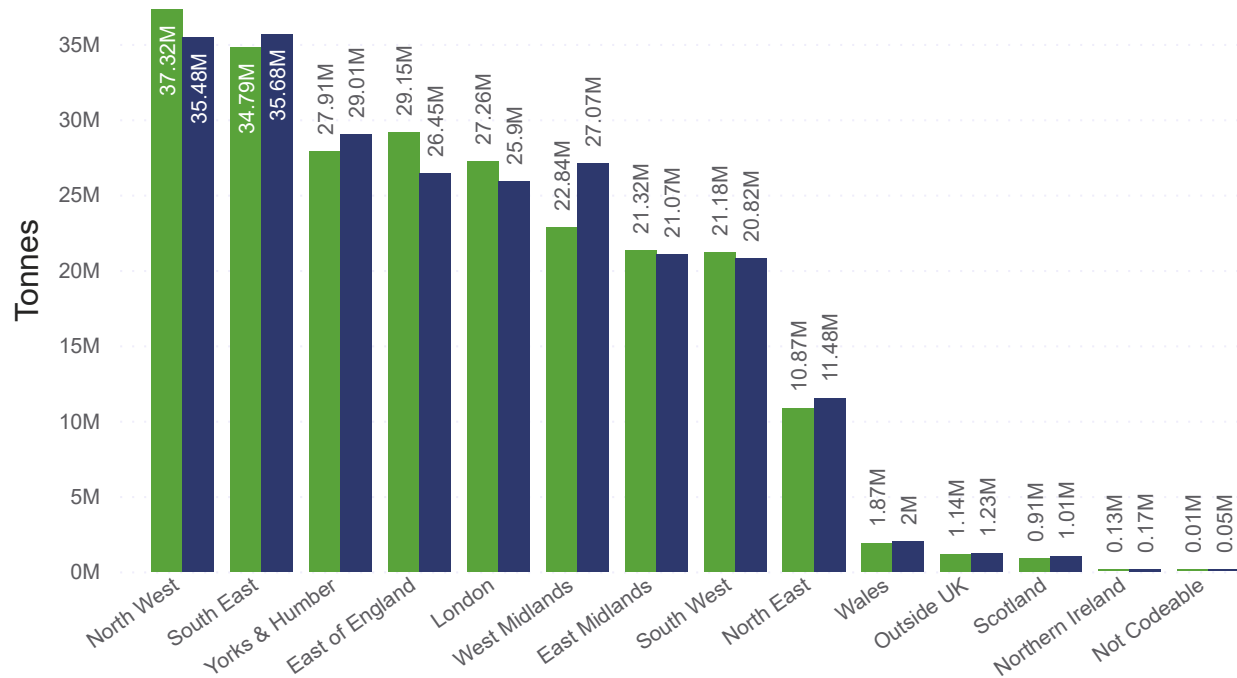

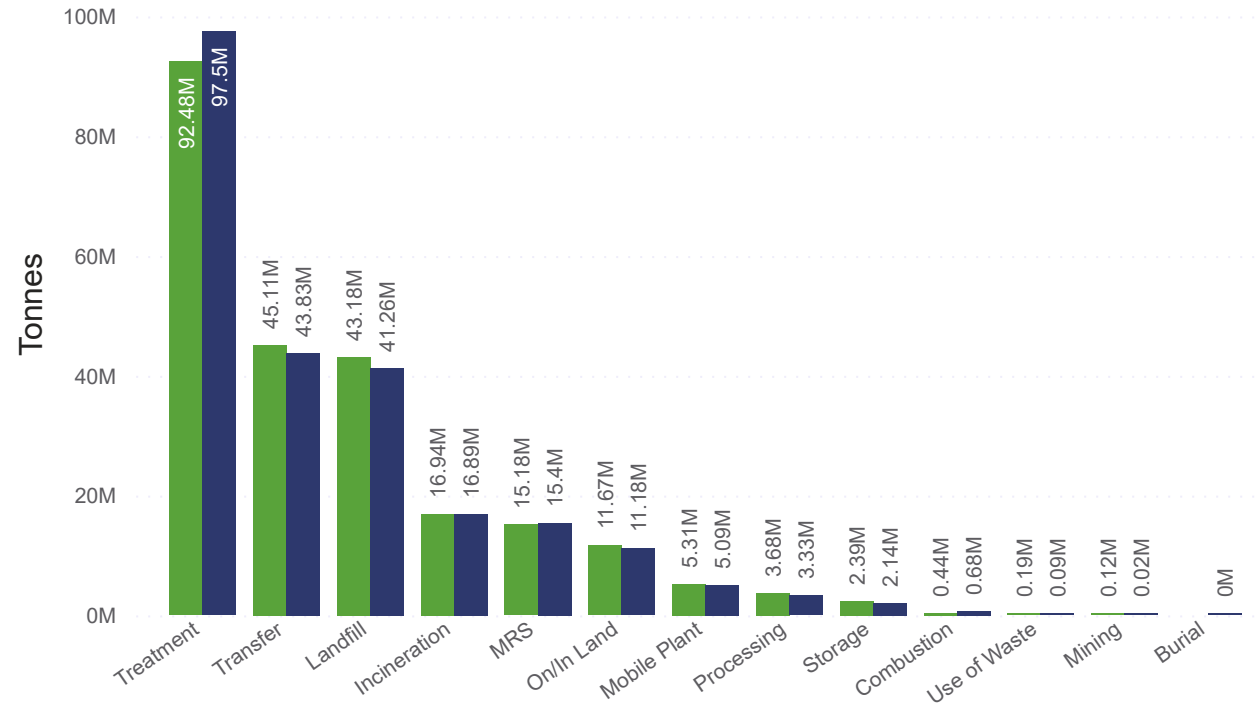

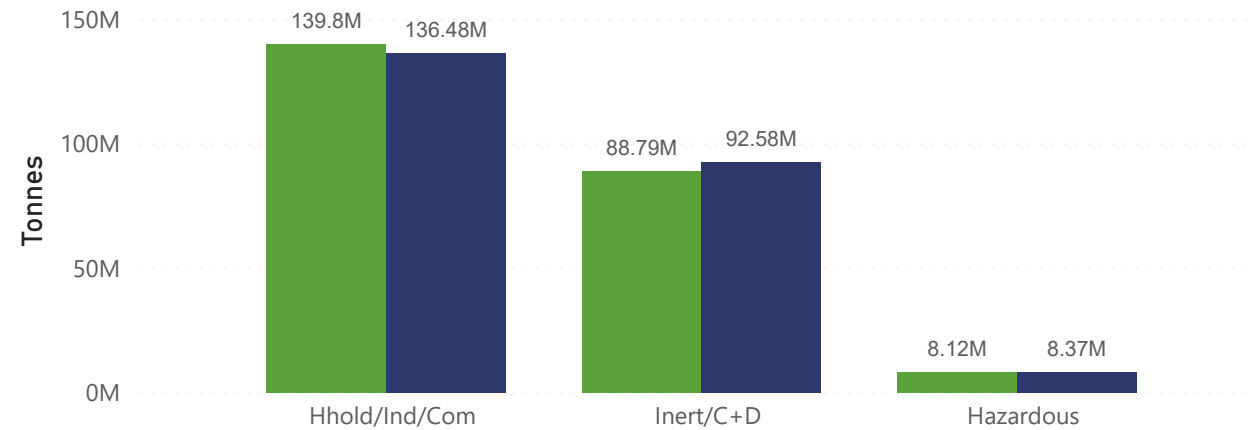
Tonnes by Site Type

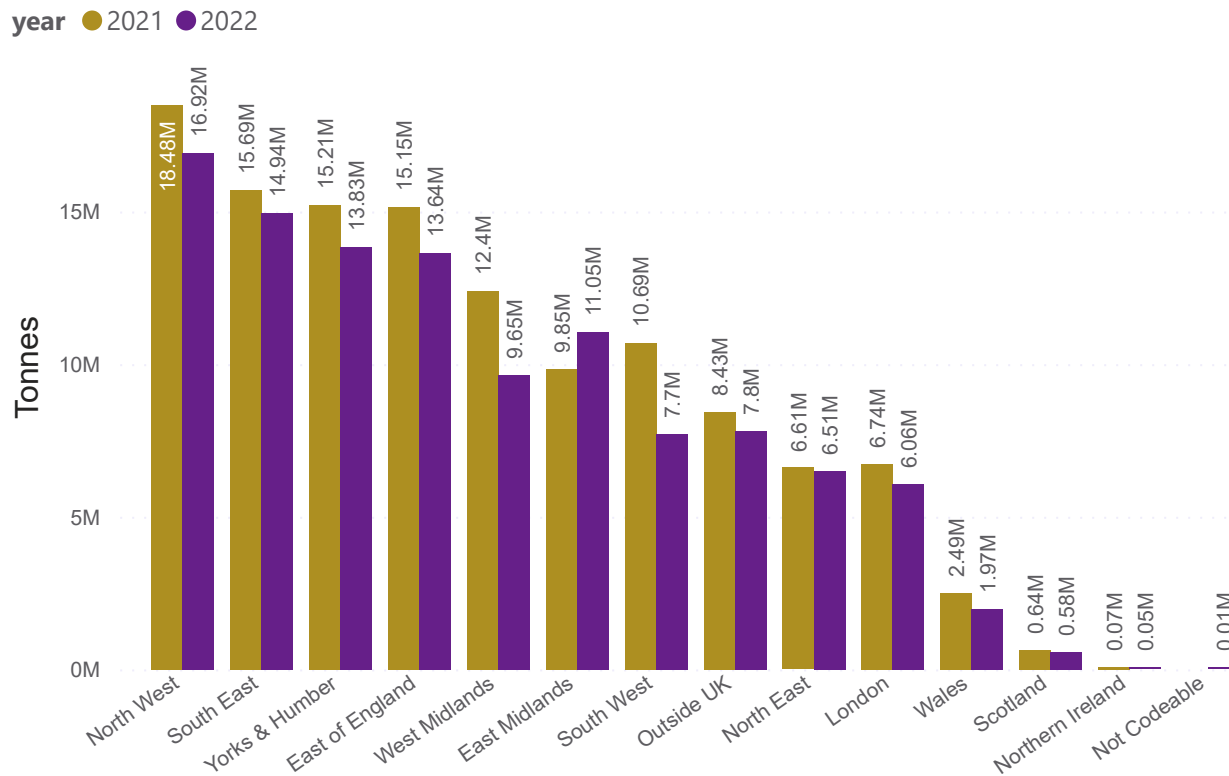

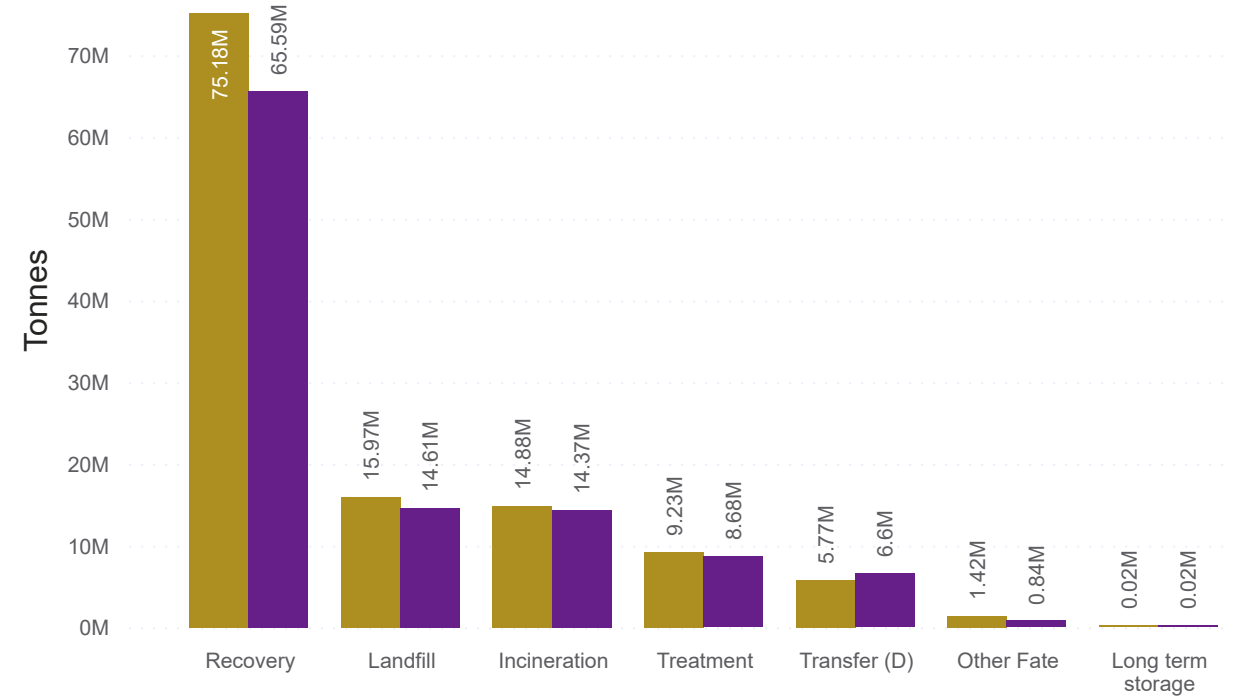


Tonnes by Destination (Region)



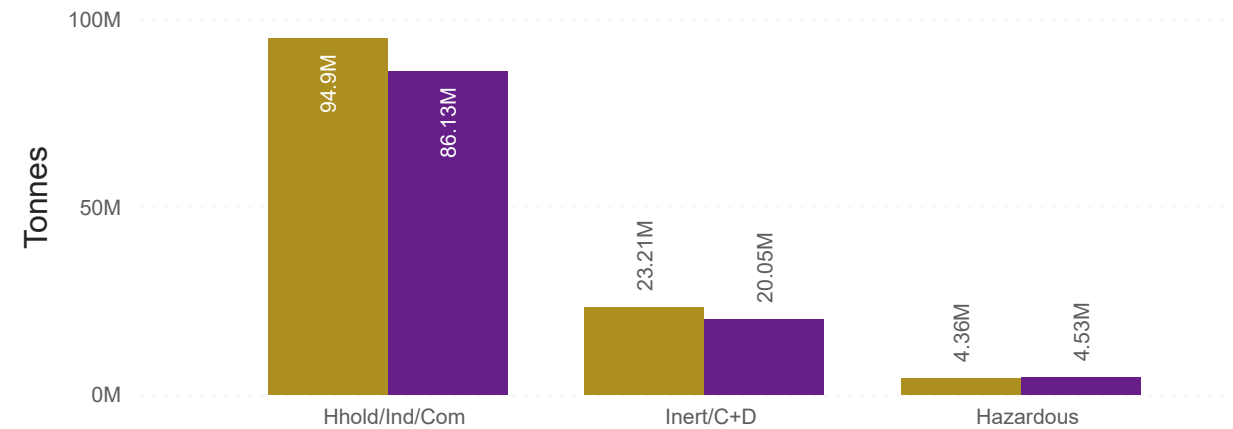

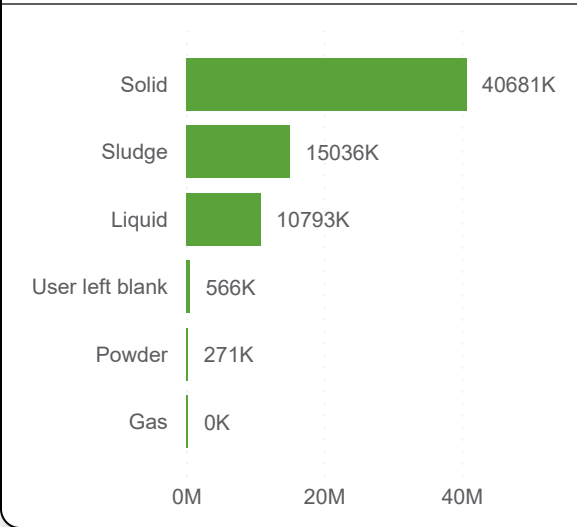


Combustible Waste (19 12 10)

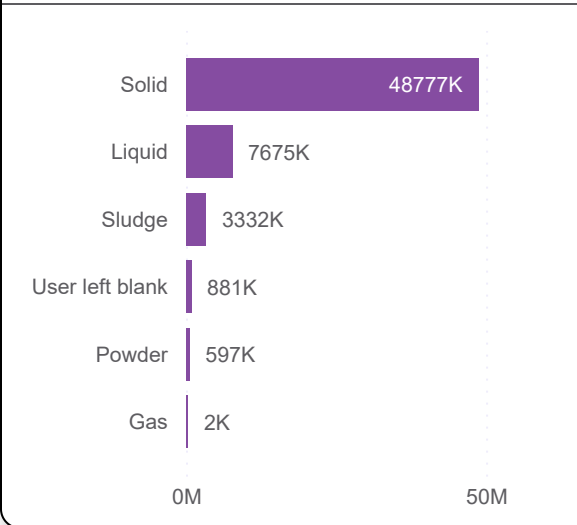

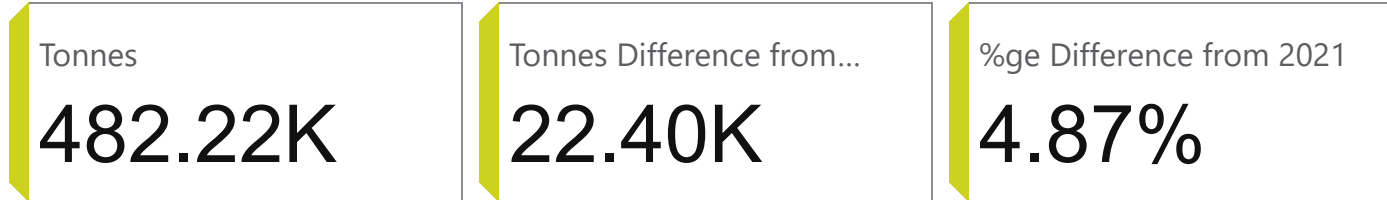
